- We seem to have a deficit for the amount we collect back from the Federal Subsidy Program. All Members on subsidy should be paying 30% of total income, but somehow Cana has calculated at 25% so we have been under charging Members. Bill is working with Lisa at Cana and she will contact all Members on subsidy.
- SOT: We will send out information on the SOT program in case we have any Member that is in need, but unaware of the program.
- No arrears reported.
- Petty Cash \$3,000.00 has been received from BC Hydro for the EV grant.
- Laundry funds have been deposited \$780.00.
